I hereby release and relieve Horse, Hound and Hunt, Catalyst Stables, LLC., Equestrian Preserve, Old Mill Farm, Anthony-Scott and Phoebe Hobbs, William Wright, and their agents, servants, volunteers, employees, officers, companies, partnerships, representatives, heirs, successors and assign each and every member of his/her family from any liability whatsoever for an loss, claim, damage, injury or death which I, my child/children, equine, canine, or any other person claiming by, through or under me may suffer or sustain as a result of interaction, travel to and from, and/or participation of any kind, equine, canine or otherwise that takes place at Old Mill Farm located at 108/118 Old Mill Road, Cartersville, GA. I hereby waive any rights I may have to bring claim or suit against any said individuals arising out of any such damage, injury or death.
